The Brevard Zoo Wildlife Emergency Fund (BZ WEF) is a small grant program that provides emergency funding (up to \$2,500) to address severe, specific, and time-sensitive threats to wildlife. Emergency funding is focused on saving wildlife impacted by unforeseen natural or man-made catastrophes.

The BZ WEF is made possible by the fundraising efforts of Brevard Zoo staff and volunteers. The ability to fulfill emergency requests is dependent upon the availability of these variable funds. As a result, only a limited number of requests are supported annually.
